No player is to leave the activity or any activity location without direct permission from the coach/organizer. Parents/Guardians, or emergency contact needs to be available to come and pick up a player in the event of injury or behavior removal from an Event.

No drugs, alcohol, tobacco or pornography is permitted. Possession of the same will result in a player being removed and notification will be given to his high school Head Coach and Athletic Director. No refund will be provided in such an event.

Player's behavior requirements DURING GAMES/SCRIMMAGES/TRAININGS:

- Never retaliate.
- Never address remarks at opposing coaches, players, referees and spectators (except for genuine friendship, respect or in response to a question by a referee).
- Avoid comments or gestures that express disagreement with the officials' calls.
- Displays of temper will not be tolerated on the field, sidelines or in the playing area.
- Convey a consistently positive attitude toward your teammates and coaches.
